Key Findings

- Almost 81% of marginalised household reported awareness of government vaccination programme while among them 45% household mentioned of 'Free vaccination programme' by the government (as of 15 June 2021). Among the households who reported of having COVID-19 symptoms (see Table 1.5 of Theme 1), 62.8% were aware of the free of cost Vaccination Programme. More than three-quarter of the ethnic and religious minority population were aware of it who leads amongst the five marginalised groups. (Tables 2.1 and 2.2)
- About 40% of the marginalised people reported that they were not aware of the location of the vaccine centers. Reportedly half of the female headed households are not aware of such centers' locations. This proportion was the highest among rural poor (46%) and half of the female-headed households was not aware of the local vaccine centers. (Table 2.3)
- More than half of the marginalised households expressed their satisfaction about the government vaccination programme while another 22% household mentioned their dissatisfaction. Only an insignificant proportion (1.3%) of the population found the programme as 'very satisfactory'. (Table 2.4)
- About half of the marginalised community people (51-46%) reported that vaccine
 would stop the spread of Corona and create immunity against Corona. However, one
 in five people believe that poorer people do not need the vaccine and 10% was worried
 about the safety and severe side effects of vaccine. Slum dwellers are found to be the
 most concerned about vaccine side effects (13%) and safety (17%). (Table 2.5)
- In general, people of marginalised communities had an optimistic view about the efficacy of the vaccines as 60% of them considered vaccine to be effective to prevent the pandemic. About 22% of the slum dwellers did not perceive vaccine necessary to combat the Corona pandemic. (Table 2.6)
- Overall, 90% households reported that none of the eligible members received vaccine as of June 15, 2021. Urban slum dwellers lead in this regard amongst the five marginalised groups. (Table 2.7)
- Public announcement over loudspeaker (81%) was reported as the most popular form
 of campaign for motivating marginalised communities to get vaccinated. The second
 most popular choice was advertisement in TV (35.5%) followed by involvement of
 community health workers (28%). Among the ethnic and religious minority, community
 health workers were mentioned by 41% households. (Table 2.8)
